

## ANNEX IV: RATES APPLICABLE FOR UNIT CONTRIBUTIONS

### KEY ACTION 1 – MOBILITY FOR ADULT EDUCATION LEARNERS AND STAFF<sup>1</sup>

#### 1. Travel

Travel distances	Standard travel - Amount	Green travel - Amount
Between 0 and 99 KM:	23 EUR per participant	
Between 100 and 499 KM:	180 EUR per participant	210 EUR per participant
Between 500 and 1999 KM:	275 EUR per participant	320 EUR per participant
Between 2000 and 2999 KM:	360 EUR per participant	410 EUR per participant
Between 3000 and 3999 KM:	530 EUR per participant	610 EUR per participant
Between 4000 and 7999 KM:	820 EUR per participant	
8000 KM or more:	1500 EUR per participant	

**Nota bene:** the "travel distance" represents the distance between the place of origin and the venue, whereas the "amount" covers the contribution to the travel both to and from the venue.

#### 2. Individual Support:

**Nota bene:** the amount per day is calculated as follows:

up to the 14<sup>th</sup> day of activity: the amount specified in the table below per day per participant  
+

from the 15<sup>th</sup> day of activity: 70% of the amount specified in the table below per day per participant.

### **3. Organisational support**

#### **100 EUR:**

- Per learner in group mobility.
- Per participant in staff mobility for courses and training
- Per invited expert
- Per hosted teacher or educator in training

Up to the 100<sup>th</sup> participant: **350 EUR**; beyond the 100<sup>th</sup> participant: **200 EUR**:

- Per participant in Individual learning mobility of adult learners
- Per participant in staff mobility for job shadowing and teaching or training assignments

**Nota bene:** Accompanying persons are not considered to be participants in learning mobility activities and are not taken into account for calculation of Organisational Support.

### **4. Course fees**

**80 EUR** per day per participant, with a maximum **800 EUR** in course fees per participant in the mobility project.

### **5. Inclusion support**

**100 EUR** per participant for costs related to the organisation of mobility activities for participants with fewer opportunities.

### **6. Preparatory visits**

**575 EUR** per participant, with a maximum of three participants per visit

### **7. Linguistic support**

**150 EUR** per participant

**Nota bene:** Individual linguistic support is not provided for staff in mobility shorter than 31 days or adult learners in group mobility.
